



## **Honda Hills Concession Policy**

1. You are representing Honda Hills and our events. We expect friendly and helpful staff, and clean and professional representation of your stand. If you have poor representation or treat guests / staff poorly, it could result in removal from the event and will affect your future attendance to our events.
2. Food concessions shall have a complete menu (approved by Honda Hills) each day of the event.
3. Every worker must have a pass to enter. Each concession trailer will be provided with 4 wristband passes for daily admission. Additional passes will need to be purchased at the gate.
4. No vehicle traffic will be permitted into the designated food concession area one hour before event scheduled start time. Supplies are to be unloaded and vehicles removed from concession area.
5. You must be open for the FULL DURATION of event times. Please plan accordingly with proper food and money supplies.
6. Disorderly people will be removed from grounds and illegally parked vehicles will be towed from grounds at owners' expense.
7. You are responsible for your employees' behavior. Any misconduct may result in removal of the vendor and denial of attendance to future events.
8. Once accepted, no refunds will be given for any reason other cancellation of the event by the HH staff.
9. No shows for event will result in denial of acceptance to future Honda Hills events.
10. No space can be sublet or substituted by a different vendor / concessionaire without prior approval of Honda Hills.
11. Concessionaire is solely responsible for compliance with all Health Department policies and procedures, permitting and licensures. Honda Hills, LLC will bear no responsibility or liability for same.
12. Proof of General Liability Insurance is required with Honda Hills, LLC listed as additional insured. Certificate of additional insured to be provided prior to the event .

I, on behalf of myself, my company, partners, employees, workers, agree to abide by the rules and regulations and acknowledge that I have received, read, and understand such rules and regulations, and further agree that my entry fee will not be refunded under any circumstances. Undersigned Exhibitor/Vendor hereby releases, waives, discharges and covenants not to sue Honda Hills, LLC, Levi Baker, Jeff Baker, any employees, volunteers, or any entity connected to the parties listed for any liability or damages it may incur by virtue of its use of the premises, including but not limited to claims of theft, property damage or personal injury incurred by me, my company, spouses, employees, helpers, or workers. This release of liability includes not only Licensee's use of the premises, but also matters arising out of adjacent sidewalks and avenues of ingress and egress.

This release explicitly and expressly is intended to release the releasees from any and all liability including but not limited to the active, passive, or gross negligence or releases. Exhibitor/vendor agrees to indemnify and hold harmless Honda Hills LLC, it's directors, officers, agents, contractors, employees, volunteers from and against any and all claims, damages, losses, and expenses (including but not limited to attorney's fees) arising out of Exhibitor's use of premises , including but not limited to claims of property damage, theft from premises, personal injury and death, regardless of whether or not the claim, damage, loss or expense is alleged to be caused in whole or in part by Licensor.

Exhibitor agrees that this is not a lease but only allows the Exhibitor/Vendor to use the space provided for the duration of the event. It is further agreed that any litigation arising out of this agreement will be held in Muskingum County, OH. Any event at Honda Hills is a juried and invitational event, and we reserve the right to reject any vendor based upon our selection process. Undersigned Exhibitor agrees that it has read, understands, and accepts all applicable rules, and has had the opportunity to contact Honda Hills with any questions prior to contract execution.
